UNITED THROUGH READING ALSO PROMOTES LITERACY BY PROVIDING BOOKS TO MILITARY CHILDREN BOTH DIRECTLY AND THROUGH PARTNERSHIPS WITH LIKE MINDED ORGANIZATIONS. THIS PROGRAM CREATES AND STRENGTHENS EMOTIONAL CONNECTIONS BETWEEN PARENTS AND THEIR CHILDREN, ENCOURAGES LITERACY AND MAKES HOMECOMING EASIER.
